### **Approval of the Name Change of the Company and Corresponding Amendments to the M&A of the Company.**

We are writing to you in your capacity as a Shareholder of the Company. The purpose of this circular is to give you notice of the Company's EGM and seek your approval of proposed changes to the M&A that will be presented at the EGM. You will find enclosed with this circular a copy of the notice of the EGM ("**Notice**") convening the Company's EGM, at which the special business will be proposed.

#### *Shareholder approval*

Federated Hermes, Inc. (formerly Federated Investors, Inc.) and Hermes Investment Management have recently taken the decision to combine their names and present as a unified global brand. "Federated Hermes" will become the sole brand for all the Federated Hermes businesses and products. As part of the rebranding, the Hermes brand will be retired and replaced with the updated Federated Hermes branding.

As a result, and subject to the consent of the Companies Registration Office, it is proposed to change the name of the Company to "Federated Hermes Investment Funds public limited company" and to amend the M&A so as to reflect the new name. These amendments require the approval of the Shareholders of the Company by means of a special resolution.

Upon the passing of the above-mentioned special resolution, the M&A will be amended accordingly to reflect the new name of the Company.

#### *Shareholder notification*

Furthermore, and subject to Central Bank approval of the proposed name changes, it is also proposed to change the names of the sub-funds of the Company, as detailed in the Appendix V herein and to rename certain share-classes of the Company, as detailed in Appendix VI. Please note that these changes do not require Shareholder approval and are set out in Appendices V and VI for notification purposes only. It is expected that these changes will occur on or around 26 June 2020, or such other date as the updated prospectus of the Company is noted by the Central Bank.

1. **Special Business**

The resolution set out in Appendix I is a special resolution which approves amendments to the M&A to reflect the change of name of the Company. A summary of these amendments is set out in Appendix IV.

2. **Procedure**

If the resolutions are passed by the requisite majority, they will be binding on all Shareholders irrespective of how (or whether) they voted, and an updated M&A reflecting the changes proposed by this circular will be filed with the Companies Registration Office and the Central Bank for formal noting in due course.

The quorum for the EGM is two Shareholders present either in person or by proxy. If within half an hour after the time appointed for a meeting a quorum is not present the meeting will be adjourned to the same day in the next week being 27 March 2020 at the same time and place or to such other time and place as the Directors may determine.

A proxy form to enable you to vote at the EGM, which will be held in Dublin, Ireland, is enclosed with this circular at Appendix II. Please read the notes printed on the form, which will assist you in its completion and return. To be valid, your proxy form must be received not later than 11.00 am (Irish time) on 18 March 2020. You may attend and vote at the EGM even if you have appointed a proxy but, in such circumstances, the proxy is not entitled to vote. If you are a corporate entity, you may wish to appoint a representative to attend and vote at the EGM on your behalf, and a form of Letter of Representation is attached as Appendix III for this purpose.

3. **Recommendation**

**The Directors are of the opinion that the proposed changes are in the best interests of the Shareholders as a whole and recommend that you vote in favour of the resolutions set out in the Notice.**
