Documents which are generally available to investors

- (b) any Key Investor Information Documents;
- (c) the Memorandum and Articles of Association of the Company; and
- (d) the latest annual and half-yearly reports of the Company (when issued).

Cessation of marketing in Denmark

In case the Company or the Sub-funds ceases marketing in Denmark, the Danish holders of shares in the Company or Sub-funds will be notified within 14 days after the decision by Hermes Investment Management Limited in writing and informed about the termination.

Redemption procedures will continue unchanged, in case the Company or the Sub-funds ceases marketing in Denmark.

The above is based on applicable rules and practice as of 26 June 2019. Danish investors should always consult their own advisers before making decisions regarding investment in the Company and its Sub-funds.
