Introduction

The purpose of this letter is to inform you of the result of an Extraordinary General Meeting of the Fund held on 21 July 2021 (the "EGM").

The Changes

At the EGM, Shareholders voted upon and passed the resolution to change the investment objective, investment policy and investment strategy of the Fund as outlined in the notice of the meeting circulated to Shareholders on 24 June 2021 (the "**Change**"). Shareholders should also note that the name of the Fund will change to Federated Hermes Sustainable European Equity Fund to better reflect the investment objective of the Fund (together with the Change, the "**Changes**").

Effective Date of the Changes

The Changes will be effective on or around the 26 October 2021.

Action to be taken

You are not required to take any action. Should you wish to convert or redeem your Shares as a result of the Changes, you are able to do so in accordance with the usual terms set out in the Prospectus. Please contact your broker or an appropriate market participant for further instructions.
