RE: Federated Hermes Unconstrained Credit Fund (a sub-fund of the Company) – Portfolio Management team update

We would like to make you aware of the following change to the investment team at Hermes Investment Management Limited, the investment manager of the Fund (the "Investment Manager"). Andrew Jackson, the Fund's co-lead portfolio manager, is leaving the Investment Manager.

As a result, Fraser Lundie, who currently shares co-lead management responsibilities for the Fund with Mr. Jackson, will become the lead portfolio manager of the Fund. Mr. Lundie will remain supported by Vincent Benguigui as co-portfolio manager and Nachu Chockalingam as sustainable portfolio manager. They will be joined by Andrew Lennox as an additional co-portfolio manager. Mr. Lennox is a senior portfolio manager in the Investment Manager, having joined the international business of Federated Hermes in April 2018. He has 20 years' experience working in financial services, of which 15 years has been in managing structured finance as a portfolio manager. In his role as senior portfolio manager, Mr. Lennox is responsible for structured credit investments across multi-asset credit portfolios. These changes to the Fund's portfolio management team have taken effect as of 14th January 2022.

The Investment Manager has always operated with a team approach to ensure that it has a strong bench of talent at its disposal in managing the sub-funds of the Company and wide alignment of investment approach. The Fund will continue to be managed in accordance with the investment strategy as described in the Supplement.
